- All booth space must be paid in full by September 1, 2010.
- Exhibitor booth space includes full pipe and drape with 10' wide x 8' high back drape, and 3' high draped side rails.
- Each exhibitor receives up to 4 exhibitor badges, 4 complimentary show passes, and a listing on the show's website. Each exhibitor can obtain a live link to their website for an annual fee of \$25.
- Six and eight foot tables will be available for \$12 each. Each front table must be skirted or covered. Skirting will be available for \$10 each. Chairs will be available for \$5 each.

- Exhibitor badges will be handed out at the show.
